PTI is a diversionary program for first time offenders that may require individual and group counseling, community service work, attending a prison tour, GET SMART, adult education or GED enrollment, paying restitution to the victim and other special conditions as determined by the program based on the crime. The prosecutor, the arresting officer and the victim(s) must be contacted for the defendant to participate.

On the enclosed form, please indicate whether you agree or disagree for the defendant to participate in PTI. If you agree, please complete the restitution section. This section pertains to restitution (money due the victim for damages and/or merchandise). If restitution is due, please provide documentation (receipts or bills) for the amount requested and address where payments are to be sent. If restitution is applicable, it should take no longer than one year to re-pay. If you filed a claim with your insurance company, please indicate the name of the company, the agent's name and the policy number. The defendant is responsible for reimbursing the insurance company as well as the victim. We value your comments and appreciate your time and effort in returning this form to our office.

Pretrial Intervention is in no way trying to make you consent. However, we find it to be a very successful program that insures the victim total repayment of monetary loss. Upon the defendant's successful completion of PTI, the charges are dismissed and no court appearance will be necessary for either party.
